- **2.** Council of Administration: Meeting will be held on 14 October 2023 @ 1pm @ The Augusta Civic Center, Augusta, ME. See attached flyer for hotel and banquet information.
- **3. ALL Commanders**: Several changes to the National By-laws were passed at the National convention. It is recommended that Post Commanders purchase a copy of the National By-laws book which is available from the VFW National Supply Catalog; item #4108, cost of the book is \$8.50. District Commanders will receive a copy at the Council of Administration.
- **4. Change of Post and District Officers**: All District and Post Commanders are reminded that whenever there is change of Officer(s) within the Post or District that they need to FILE NEW ELECTION REPORT and notify the State Adjutant Office ASAP so that the Department directory can be updated accordingly, and the information disseminated to all in the General Orders.
- **5. Post Commanders**: Please refer to the National Manual of Procedure Article II; Section 205 when any changes need to be made to Chartered or regular meetings.

- **6. Chain of Command:** All Posts members are reminded that if there are any issues at your Posts, it is asked that you start at that level with the Post Commander, then the District Commanders and finally the State Commander. In most cases/situations, problems can be resolved at the post level.
- **7. District/Post By-Laws:** Districts and Posts Commanders are reminded to look at when you last updated your by-laws. If it has been more than 5 years, you need to look at them and update them. Please use the correct templates as provided by National Headquarters or contact the State Adjutant office who will email you the current template. Once completed, please forward 3 originals signed to State Adjutant's office for review and then forwarding to National for approval. Several Posts and Districts this past year have submitted changes and were approved by National.
- **8. District Meetings Date Changes**: District Commanders are reminded to notify the State Adjutant office ASAP of any changes in District meeting dates so that the respective Department Representative can be notified in plenty of time.
- **9. Post Commanders:** Each post shall see that suitable programs are made for observance of Veterans Day. (National Manual of Procedure Article II; Section 223).
- **10. Candidates for High Office 2023-24**: Any member wishing to run for any high office are to notify the State Adjutant office via e-mail of their intent for publishing in the GOs.
- **11. Post, District Commanders, Adjutants and Quartermasters:** Are reminded of the requirements of Sections 216, 416 and 516 of the Manual of Procedure regarding proof of eligibility for all newly elected and appointed officers. Elected and appointed officers shall not be installed or assume the duties of their office until proof of eligibility has been submitted and properly reviewed. Failure or refusal to submit proof of eligibility within thirty (30) days of election or appointment shall result in the office being declared vacant.
- 12. Officers Duties: Article II, Section 218 Officers and Chairman, Duties and Obligations (a) Officers (1) Duties of Commander item (k) "Assure that the Commander or their representative attend all properly called District conventions or meetings." Post Commander must attend District meetings. Failure without just cause to perform these duties may result in removal from office. All Post Senior and Junior Vice Commanders are urged to attend all District meetings planned. The Post Commanders should employ all elected Post Officers and post members to attend District meetings.
- 13. Control of Units: National By-laws: Article VII Section 709: ¶1: "Any activity, clubroom, holding company or unit sponsored, conducted or operated by, for or on the behalf of a Post, County Council, District, or Department shall be at all times under the direct control of such Post, District, or Department and that all funds derived there from shall be at all times under the direct control of such Post, County Council, District or Department." National By-laws: Article VII Section 709: ¶2: "All money, property or assets of any kind or nature, as well as all books and records, owned, held, or used by any activity, clubroom, holding company or unit sponsored, conducted or operated by, for or in behalf of a Post, County Council, District or Department shall be the property of such Post, County Council, District, or Department shall be the property of such Post, County Council, District or Department and must be placed in the care and custody of the respective Quartermaster. Such money, property, assets, books, and records shall be subject to the same rules and under the same procedure as any other Post, County Council, District or Department money, property, assets, books, and records."

- 3. Jaw, neck, or back pain (although all these signs apply to both men and women, this one seems to be more prevalent in women).
- 4. Discomfort or pain in arm or shoulder.
- 5. Shortness of breath.

If you, or someone you know is experiencing any of these, call 911, time matters. 1. The Service Office is open. We officially reopened our doors on 01 May 2023 in accordance with VBA and VHA policy change. VHA is still maintaining two entry points for now, Bldg 200(main hospital) and Bldg 205(primary care). A mask is not required unless you are suffering from a cold, flu or Covid symptoms or you are going to. an area where contagion is high ie: (ICU, Urgent Care, CLC unit) just to name a few. So, we still continue to do appointments (this helps us with time management) and walk-in traffic for disability claims issues. We welcome social calls but ask that you limit them to as short as possible so we can focus on the work at hand. Remember we are here to help and assist you, so please reach out to us as the need arises. You can continue to reach us at the VFW Service Office phone number (207)623-5723. Or send mail to:

- 2. Be vigilant of PACT Act scammers. Scammers are taking advantage of new opportunities to commit fraud. There's been an increase in PACT Act-related phishing (email), vishing (phone), and social media scams targeting Veterans to access their PACT Act benefits or submit claims on their behalf. Veterans should be cautious of anyone who guarantees a lucrative financial benefit or service. To report suspected fraudulent activity, please contact VA at vaoighotline@va.gov or call (800) 488-8244. Tips for Veterans, survivors, and dependents who are potentially eligible for VA benefits:
- ② Do not provide personal, benefits, medical, or financial details online or over the phone.
- 2 Federal agencies will not contact you unless you make a request.
- Enable multi-factor authentication on all accounts.
- 2 Work with accredited Veteran service providers
- ② Do not click on online ads or engage with social media that seem suspicious.
- 3. PACT ACT Referrals VFW launched a new initiative to inform veterans of www.pactactinfo.org, a website that streamlines referrals to our cadre of accredited service officers for VA Disability Claims related to the PACT Act. When a veteran visits the site, they can answer a short series of questions to determine if they are potentially eligible for benefits and can also request that an accredited representative contact them to discuss their claim.
- 4. Upcoming NVS Skill Level Training. The office will be closed 11-15 September while the DSO staff are attending NVS training in Annapolis MD. Please contact the Togus Benefits Office at (207)621-6938 for assistance in our absence.
- 5. PACT Act retro deadline. August 9th is the deadline for filing paperwork with VA to get an August 10 th 2022 effective date of claim. You must have an active claim or an Intent to file on record with VA by the 9 th to qualify for the 10 August effective date. Any paperwork that is not associated with an intent to file or active claim will have an effective date established when the claim paperwork is filed. Get your paperwork to your DSOs as soon as possible.

Credentials: 53% of Posts in the Department were eligible to vote at the Department Convention this year, next year my goal is 75%, let's all work together to meet that percentage next year! We can do that by starting off strong addressing most of the requirements to vote this summer! Per National and State By-Laws, to vote at the State Convention you must have turned in all 4 Trustees Reports, 1 of which should have been turned in at this point. Your Post must also be inspected, your Quartermaster must be Bonded, all monies owed to the Department must be paid, and ALL Post and Districts are required to be incorporated. Check the State Quartermasters hitlist in these GOs to ensure you are aware of all these items and where you stand. Your Post is entitled to 1 delegate and 1 alternate per every 30 members in good standing as of March 31st of next year and has paid a registration fee for every delegate. You can vote as a Post Commander (1 Vote) or on behalf of them if you are a Post Senior or Junior Vice Commander, but you cannot then vote as a Post Delegate if you do.
