- **2.** Council of Administration: Meeting will be held on 14 October 2023 @ 1pm @ The Augusta Civic Center, Augusta, ME. See attached flyer for hotel and banquet information.
- **3.** Having been duly elected and installed as Department Commander... "I, John Bouchard, hereby assume command of the Department of Maine, Veterans of Foreign Wars of the United States.
- **4. Change of Post and District Officers**: All District and Post Commanders are reminded that whenever there is change of Officer(s) within the Post or District that they need to FILE NEW ELECTION REPORT and notify the State

Adjutant Office ASAP so that the Department directory can be updated accordingly, and the information disseminated to all in the General Orders.

- **5. Directory for 2023-24**: Has been completed and all information was derived from the election reports as received from both the Posts and Districts. They will be mailed in July with all of the yearly information as provided to the Posts, Districts and Departments Council and Chairman. Everyone receiving the directory is asked to make sure that the information is correct, if needed to be corrected, please email the information to the state Adjutant office. We are in hopes that we will have at least an email addy for either the Commander, Quartermaster or Adjutant but preferably all 3 officers
- **6. Chain of Command:** All Posts members are reminded that if there are any issues at your Posts, it is asked that you start at that level with the Post Commander, then the District Commanders and finally the State Commander. In most cases/situations, problems can be resolved at the post level.
- **7. Attention of Post Commanders is directed to Section 222 of the National Bylaws and the Manual of Procedure:** Provides that each Post will pay, in advance, a National Convention registration fee of twenty-five dollars (\$25) which shall entitle the Post to a packet of convention information and materials and one identified registered delegate for the National Convention. Each additional delegate attending the National Convention will pay a ten dollar (\$10) delegate fee. Posts are encouraged to register their Post delegate online through the Online Membership System (OMS) or by submitting their National Convention Post and Delegate Registration form that was mailed to all Posts as part of the Election Report/Convention Registration mailing that went out in February. Advanced registration for the 124th National Convention should be mailed with each delegate's name and address to: Convention Registration, 406 W. 34th Street, Kansas City, MO 64111.
- **8. District/Post By-Laws:** Districts and Posts Commanders are reminded to look at when you last updated your by-laws. If it has been more than 5 years, you need to look at them and update them. Please use the correct templates as provided by National Headquarters or contact the State Adjutant office who will email you the current template. Once completed, please forward 3 originals signed to State Headquarters for review and then forwarding to National for approval. Several Posts and Districts this past year have submitted changes and were approved by National.
- **9. District Meetings Date Changes**: District Commanders are reminded to notify the State Adjutant office ASAP of any changes in District meeting dates so that the respective Department Representative can be notified in plenty of time.
- **10. Commanders:** Attention is directed to Section 213 of the National By-Laws concerning any Post in arrears for any financial obligations to District, Department and National for fees, dues, poppy money, supply money, failing to have the office of the Quartermaster properly bonded in accordance with Section 703, failing to ensure that the Post is properly insured IAW with Section 709, failing to submit properly completed quarterly Post Trustees Report of Audit, Post Election Report for the ensuing year, or other obligations, shall be deprived of all representation in District meetings; District, Department and National Conventions. Such representation shall be restored promptly upon proper adjustments of such deficiencies.

- **11. Candidates for High Office 2023-24**: Any member wishing to run for any high office are to notify the State Adjutant office via e-mail of their intent for publishing in the GOs.
- **12. Post, District Commanders, Adjutants and Quartermasters:** Are reminded of the requirements of Sections 216, 416 and 516 of the Manual of Procedure regarding proof of eligibility for all newly elected and appointed officers. Elected and appointed officers shall not be installed or assume the duties of their office until proof of eligibility has been submitted and properly reviewed. Failure or refusal to submit proof of eligibility within thirty (30) days of election or appointment shall result in the office being declared vacant.
- 13. Officers Duties: Article II, Section 218 Officers and Chairman, Duties and Obligations (a) Officers (1) Duties of Commander item (k) "Assure that the Commander or their representative attend all properly called District conventions or meetings." Post Commander must attend District meetings. Failure without just cause to perform these duties may result in removal from office. All Post Senior and Junior Vice Commanders are urged to attend all District meetings planned. The Post Commanders should employ all elected Post Officers and post members to attend District meetings.
- 14. Control of Units: National By-laws: Article VII Section 709: ¶1: "Any activity, clubroom, holding company or unit sponsored, conducted or operated by, for or on the behalf of a Post, County Council, District, or Department shall be at all times under the direct control of such Post, District, or Department and that all funds derived there from shall be at all times under the direct control of such Post, County Council, District or Department." National By-laws: Article VII Section 709: ¶2: "All money, property or assets of any kind or nature, as well as all books and records, owned, held, or used by any activity, clubroom, holding company or unit sponsored, conducted or operated by, for or in behalf of a Post, County Council, District or Department shall be the property of such Post, County Council, District, or Department shall be the property of such Post, County Council, District or Department and must be placed in the care and custody of the respective Quartermaster. Such money, property, assets, books, and records shall be subject to the same rules and under the same procedure as any other Post, County Council, District or Department money, property, assets, books, and records."

1. Re-opening of the Service Office. We officially reopened our doors on 01 May 2023 in accordance with VBA and VHA policy change. They are still maintaining two entry points for now, Bldg. 200(main hospital) and Bldg. 205(primary care). A mask is not required unless you are suffering from cold, flu or Covid symptoms or you are going to an area where contagion is high i.e.: (ICU, Urgent Care, CLC unit) just to name a few. So we continue to do appointments (this helps us with time management) and walk-in traffic for disability claims issues. We welcome social calls but ask that you limit them to as short as possible so we can focus on the work at hand. - 2. Be vigilant of PACT Act scammers. Scammers are taking advantage of new opportunities to commit fraud. There's been an increase in PACT Act-related phishing (email), vishing (phone), and social media scams targeting Veterans to access their PACT Act benefits or submit claims on their behalf. Veterans should be cautious of anyone who guarantees a lucrative financial benefit or service. To report suspected fraudulent activity, please contact VA at vaoighotline@va.gov or call (800) 488-8244. Tips for Veterans, survivors, and dependents who are potentially eligible for VA benefits:
- ② Do not provide personal, benefits, medical, or financial details online or over the phone.
- Pederal agencies will not contact you unless you make a request.
- Enable multi-factor authentication on all accounts.
- Work with accredited Veteran service providers
- ② Do not click on online ads or engage with social media that seem suspicious.
- 3. PACT ACT Referrals VFW launched a new initiative to inform veterans of www.pactactinfo.org, a website that streamlines referrals to our cadre of accredited service officers for VA Disability Claims related to the PACT Act. When a veteran visits the site, they

can answer a short series of questions to determine if they are potentially eligible for benefits and can also request that an accredited representative contact them to discuss their claim.

4. Operation at Ease Operation at Ease is VBAs latest PACT Act event. This event will be very. like the outdoor event VBA held in Scarborough, ME in the Cabela's parking lot and the indoor event they held in Bangor, ME at the Anah Shriner's facility.

Credentials: I want to thank the 20 Posts that sent me their Credentials for the State Convention! Overall, there were 24 Posts that voted at the State Convention in June, with 2 other Posts eligible to vote but not attending the Convention, that is 53% of Posts in the Department voting, let's all work together to increase that percentage next year! We can do that by starting off strong addressing most of the requirements to vote this summer! Per National and State By-Laws, to vote at the State Convention you must have turned in all 4 Trustees Reports, 1 of which should have been turned in at this point. Your Post must also have been inspected, your Quartermaster must be Bonded, all monies owed to the Department must be paid, and ALL Post and Districts are required to be incorporated. Check the State Quartermasters hitlist in these GOs to ensure you are aware all these items and where you stand. Your Post is entitled to 1 delegate and 1 alternate per every 30 members in good standing as of March 31 st of next year and has paid a registration fee for every delegate. You can vote as a Post Commander (1 Vote) or on behalf of them if you are a Post Senior or Junior Vice Commander, but you cannot then vote as a Post Delegate if you do. HOMELESS VETERANS VETERANS CEMETERY SOUTH ~ ASSISTANT LEGISLATIVE (Augusta) James Bachelder

Homeless Veterans: According to the Point-in-Time Survey found 132 homeless Veterans. The total homeless individuals located this year was 4258. There were 1099 chronically homeless persons found in the 2023 survey. Maine Veterans in Need (MVN): The \$10,000.00 Department of Labor grant is being handled by MVN. The information number for services is 211. MVN was added as a contact for homeless Veterans. Our phone service is provided by the resource center in Brunswick. The level of calls is unmanageable. 211 will need to prioritize the calls and call the VA, MBVS, Preble Street, Fedcap and VOA during business hours. MVN is the only phone number that is available 24/7 for after business hours. MVN presented a position paper to the Governor during the Aid-deceCamp meeting. It created some discussion from Department of Public Safety Commissioner Mike Sauschuck and Department of Correction Commissioner Randall Liberty. MBVS has funds that can be used for VEFAP. It may help the non-profits that can't afford to cover all the Veterans in Needs requests. We need a lot of affordable housing.

Veterans' Cemetery South:

The three-sided enclosure of the committal shelter is paid off. The job cost \$32,434.00. It is nice not having the weather blown thru the shelter. The state has a new superintendent for the cemetery system, Chip Jones.

We ordered 100 niche wall vases, and the manufacturer donated them at a cost of \$3,918.00. We also ordered 24 in the ground vases and received 32. The company said to keep them. That is a savings of \$278.80. The Surveying for the crosses that will be placed behind the POW/MIA Memorial will represent those who will not be returned for burial. The Brad Hoffman honors the stone ride raised \$3221.97 for the Women's Veteran Memorial.
