- **2.** Council of Administration: Meeting will be held on 14 October 2023 @ 1pm @ The Augusta Civic Center, Augusta, ME. See attached flyer for hotel and banquet information.
- **3. ALL Commanders**: Several changes to the National By-laws were passed at the National convention. It is recommended that Post Commanders purchase a copy of the National By-laws book which is available from the VFW National Supply Catalog; item #4108, cost of the book is \$8.50. District Commanders will receive a copy at the Council of Administration.

- **4. Change of Post and District Officers**: All District and Post Commanders are reminded that whenever there is change of Officer(s) within the Post or District that they need to FILE NEW ELECTION REPORT and notify the State Adjutant Office ASAP so that the Department directory can be updated accordingly, and the information disseminated to all in the General Orders.
- **5. All Commanders: Section 209 Consolidation of Posts:** Two or more Posts may consolidate upon a vote of their respective members conducted in accordance with the procedures herein set forth as follows:
- >A motion to consider consolidation shall be made and approved at a regular or special meeting of the Posts.
- >A committee shall be appointed by the Post Commander to investigate consolidation.
- >All Posts involved in the consolidation shall exchange a report of all assets and liabilities.
- >A Post may then, after at least twenty (20) days written notice to the Department Commander, District Commander and members of the respective Posts, consolidate upon a 2/3 vote of the members present and voting at each regular or special meetings of the respective Posts.
- >The Department Commander shall be notified, in writing, immediately after the meeting of the outcome of the action taken.
- >A Department representative shall conduct a joint meeting of all Posts within thirty (30) days for the purpose to determining the name, number (must be one of the consolidating Post Numbers), location of the consolidated Post and the election and installation of officers. A written notice must be sent to the members of all Posts involved at least fourteen (14) days in advance. All actions, except for the election of officers, must be approved by a two-thirds (2/3) vote of the members present and voting.
- >Such facts shall be certified by the Department representative, submitted to the Department Commander for forwarding to the Commander-in-Chief who shall issue a Certificate of Charter reciting the facts of such consolidation. The Certificate of Charter shall rank from the date of the senior Post's charter. The property of each of the Posts shall be conveyed to and become the property of rank as of date of service in their respective Posts.

Notwithstanding the provisions above, the Department Commander may recommend consolidation to the Commander-in-Chief as circumstances dictate.

- **6. Chain of Command:** All Posts members are reminded that if there are any issues at your Posts, it is asked that you start at that level with the Post Commander, then the District Commanders and finally the State Commander. In most cases/situations, problems can be resolved at the post level.
- **7. Attention of Post Commanders is directed to Section 222 of the National Bylaws and the Manual of Procedure:** Provides that each Post will pay, in advance, a National Convention registration fee of twenty-five dollars (\$25) which shall entitle the Post to a packet of convention information and materials and one identified registered delegate for the National Convention. Each additional delegate attending the National Convention will pay a ten dollar (\$10) delegate fee. Posts are encouraged to register their Post delegate online through the Online Membership System (OMS) or by submitting their National Convention Post and Delegate Registration form that was mailed to all Posts as part of the Election Report/Convention Registration mailing that went out in February. Advanced registration for the 124th National Convention should be mailed with each delegate's name and address to: Convention Registration, 406 W. 34th Street, Kansas City, MO 64111.

- **8. District/Post By-Laws:** Districts and Posts Commanders are reminded to look at when you last updated your by-laws. If it has been more than 5 years, you need to look at them and update them. Please use the correct templates as provided by National Headquarters or contact the State Adjutant office who will email you the current template. Once completed, please forward 3 originals signed to State Headquarters for review and then forwarding to National for approval. Several Posts and Districts this past year have submitted changes and were approved by National.
- **9. Trustee's Report of Audit:** Post/District are reminded to forward their Trustees' reports at the end of each quarter of current year: June 30, Sep 30; Dec 31 and Mar 31; send these reports as soon as possible after each quarter to the Department Quartermaster.
- **10. Post Commanders:** Each post shall see that suitable programs are made for observance of Veterans Day. (National Manual of Procedure Article II; Section 223).
- **11. Candidates for High Office 2023-24**: Any member wishing to run for any high office are to notify the State Adjutant office via e-mail of their intent for publishing in the GOs.
- **12.** The National Bylaws provide for only one type of membership: active membership. There are no provisions in the National Bylaws, nor is there any authority or justification for issuance of Club Membership cards, Associate Member cards, Honorary Membership cards, Courtesy Membership cards or any other special type of cards. Any Post issuing such unauthorized cards, or conducting club operations open to the general public, endangers its standing with the Internal Revenue Service as a non-profit organization. Officers signing outlaw cards admitting non-members to VFW premises are subject to disciplinary action. National and Department officers cannot defend practices that conflict with VFW Bylaws or procedures.
- 13. Officers Duties: Article II, Section 218 Officers and Chairman, Duties and Obligations (a) Officers (1) Duties of Commander item (k) "Assure that the Commander or their representative attend all properly called District conventions or meetings." Post Commander must attend District meetings. Failure without just cause to perform these duties may result in removal from office. All Post Senior and Junior Vice Commanders are urged to attend all District meetings planned. The Post Commanders should employ all elected Post Officers and post members to attend District meetings.
- 14. Control of Units: National By-laws: Article VII Section 709: ¶1: "Any activity, clubroom, holding company or unit sponsored, conducted or operated by, for or on the behalf of a Post, County Council, District, or Department shall be at all times under the direct control of such Post, District, or Department and that all funds derived there from shall be at all times under the direct control of such Post, County Council, District or Department." National By-laws: Article VII Section 709: ¶2: "All money, property or assets of any kind or nature, as well as all books and records, owned, held, or used by any activity, clubroom, holding company or unit sponsored, conducted or operated by, for or in behalf of a Post, County Council, District or Department shall be the property of such Post, County Council, District, or Department shall be the property of such Post, County Council, District or Department and must be placed in the care and custody of the respective Quartermaster. Such money, property, assets, books, and records shall be subject to the same rules and under the same procedure as any other Post, County Council, District or Department money, property, assets, books, and records."

Immediate Past State Commander/CSP: I want to thank the entire membership for the outstanding. work and efforts made during the 2022-2022 year to make Maine an All-American Dept. I want to update you on my Commander's Special Project – There was an unclaimed prize of \$2,000 and it has been turned back over to the CSP. This brings our total to over \$9,000 for Veterans Family Camp! Way to go! Two of the winners donated some of their winnings back to us; I have donated that to this year's CSP to start out the funds. Please support Commander Bouchard with his CSP "Make a Wish" this year, as you did for me.

Grants: Our State of Maine VSO Grant \$60,000.00 is on track, and we received a check for \$13,002.50. Our VA Transportation New Grant the \$37,344.00 up and running. We have applied for the 2023-2024 Transportation Grant and are awaiting final approval. After several years of not receiving funds from the State of Maine Homeless Veterans Grant, we are awaiting a check for \$5,630.97.

Veterans and Military Support (VMS): DID YOU KNOW? VMS is an umbrella for the Unmet Needs, Sport Clips Help a Hero Scholarship, Student Veterans Support Grant, Military Assistance Program (MAP) and Adopt-a-Unit programs. Burger King is the primary supporter of the Unmet Needs Program, which. provides grants up to \$1,500 to qualifying veterans in need. Burger Kings franchises that are enrolled in. this program has their fundraising efforts conducted in July and November. Please support your local franchise in their fundraising efforts. 1. The Service Office is open. We officially reopened our doors on 01 May 2023 in accordance with VBA and VHA policy change. VHA is still maintaining two entry points for now, Bldg 200(main hospital) and Bldg 205(primary care). A mask is not required unless you are suffering from a cold, flu or Covid symptoms or you are going to. an area where contagion is high ie: (ICU, Urgent Care, CLC unit) just to name a few. So, we still continue to do appointments (this helps us with time management) and walk-in traffic for disability claims issues. We welcome social calls but ask that you limit them to as short as possible so we can focus on the work at hand. Do not provide personal, benefits, medical, or financial details online or over the phone.

Federal agencies will not contact you unless you make a request.

Enable multi-factor authentication on all accounts.

Work with accredited Veteran service providers

Do not click on online ads or engage with social media that seem suspicious.

PACT ACT Referrals VFW launched a new initiative to inform veterans of www.pactactinfo.org, a website that streamlines referrals to our cadre of accredited service officers for VA Disability Claims related to the PACT Act. When a veteran visits the site, they can answer a short series of questions to determine if they are potentially eligible for benefits and can also request that an accredited representative contact them to discuss their claim.

- 4. Upcoming NVS Skill Level Training. The office will be closed 11-15 September while the DSO staff are attending NVS training in Annapolis MD. Please contact the Togus Benefits Office at (207)621-6938 for assistance in our absence.
- 5. PACT Act retro deadline. August 9^{th} is the deadline for filing paperwork with VA to get an August 10 th 2022 effective date of claim. You must have an active claim or an Intent to file on record with VA by the 9 th to qualify for the 10 August effective date. Any paperwork that is not associated with an intent to file or active claim will have an effective date established when the claim paperwork is filed. Get your paperwork to your DSOs as soon as possible.
