- **2.** Council of Administration: Meeting will be held on 20 April @ 1pm @ Caribou Inn and Convention, Caribou ME. See attached flyer for hotel and banquet information.
- **3. Proof of Eligibility Requirements for Officers:** All Posts, Districts and Departments should be reminded of the provisions of Sections 216, 416, and 516 of the Manual of Procedure that officers, elected and appointed, shall not be installed, or assume the duties of their office until proof of eligibility has been submitted to the respective Adjutant and properly reviewed.
- **4. PCI Publishing:** The Department is working with PCI Publishing to create an oral history of our members. They are sending out yellow postcards to all our members, they will continue to send out these postcards until August of 2024. There is no obligation to call, but they will keep sending postcards until you do or August.
- **5.** Attention of Post Commanders is directed to Section 222 of the National Bylaws and the Manual of Procedure, which provides that each Post will pay, in advance, a National Convention registration fee of twenty-five dollars (\$25) which shall entitle the Post to a packet of convention information and materials and one identified registered delegate for the National Convention. Each additional delegate attending the National Convention will pay a ten-dollar (\$10) delegate fee. Posts are encouraged to register their Post delegate(s) online through the Online Membership System (OMS) or by submitting their National Convention Post and Delegate Registration form that will be mailed to all Posts as part of the Election Report/Convention Registration mailing going out later this month. Registration forms for the 124th National Convention may be mailed to: Convention Registration, 406 W. 34th Street, Kansas City, MO 64111.
- **6. Section 222 of the National Bylaws and the Manual of Procedure** provides that delegates and alternates for the District Convention and meetings, Department and National Conventions shall be elected at a regular meeting in April. Posts are entitled to one (1) delegate and one (1) alternate for each thirty (30) members or fraction thereof in good standing in the Post as of March 31.
- **7. Attention is directed to Section 217 of the National Bylaws and the Manual of Procedure** covering the nomination, election, and installation of Post Officers. Post Election Report forms are being mailed to Post Quartermasters with instructions that they complete the form online through the Online Membership System (OMS) or they can complete the form and return directly to National Headquarters immediately following the election of Post Officers but not later than June 1.
- **8. Resolutions:** Posts desiring to submit resolutions for consideration by their District prior to the convening to the State Convention must present the resolution to their District in time for their District Conventions and upon approval by the District, copies of the resolution must reach the Department Adjutant in time to be prepared for the State Convention.
- **9.** Attention of Post Commanders is directed to Section 218 (a)(11) of the National Manual of Procedure, Officers: Duties and Obligations. The Trustees Report of Audit must be prepared in detail within thirty (30) days from the end of each quarter, one of which ends March 31.

- **10. Checks Sent to Department of Maine:** When forwarding checks to our State Quartermaster, please note that checks are to be made out to "Department of Maine, VFW" and in the memo line, note the name of the program it is for.
- **11. Candidates for High Office 2023-24**: Any member wishing to run for any high office are to notify the State Adjutant office via e-mail of their intent for publishing in the GOs.
- **12. Convention Book Advertising: Consult Tele-Communications from Londonderry, NH** is soliciting ads for our State Convention book throughout the State of Maine. Any business calling your Post respectively, inquiring about the solicitation, please inform them that they are the sole company that sells ads for the Department of Maine.
- 13. Officers Duties: Article II, Section 218 Officers and Chairman, Duties and Obligations (a) Officers (1) Duties of Commander item (k) "Assure that the Commander or their representative attend all properly called District conventions or meetings." Post Commander must attend District meetings. Failure without just cause to perform these duties may result in removal from the office. All Post Senior and Junior Vice Commanders are urged to attend all District meetings planned. The Post Commanders should employ all elected Post Officers and post members to attend District meetings.
- 14. Post Commanders: Sections 219 and 704 of the Manual of Procedure outline the various things for which the Post Relief Fund can be used. Several years ago, the phrase "To foster true patriotism through, historical and education programs," was added to this section. This allows the Post to use the relief funds for the Voice of Democracy program or other Americanism programs that are educational. This does not include Post building projects, hall remodeling, color guard uniforms or any other expenditure that does not follow these guidelines.

Chaplains will need to provide ministry to people wherever there is a need.

QUALIFICATIONS OF CHAPLAINS

The qualifications for the Veterans of Foreign Wars Chaplain are not academic or ecclesiastical. A VFW Chaplain candidate is not required to be a professional" clergy person. (Most Post/Auxiliary Chaplains are not.)

National Council Member – Maine – I have a National Council of Administration meeting in March at the National Legislative Conference in Washington DC. Prior to the council meeting I will have my Budget and Finance Committee meeting and a council workshop. It will be busy but productive.

Legislation – By the time you get this I will be off to DC for the National Legislative Conference and National Council of Administration. It will be a jam packed 5 days for me with two days of travel. I look forward to watching the Chief's Testimony and meeting with all four of our Legislators. 1. Service Office visit procedures. VHA is still maintaining two entry points for now, Bldg. 200(main hospital) and Bldg. 205(primary care). A mask is not required unless you are suffering from cold, flu or Covid symptoms or you are going to an area where contagion is high i.e.: (ICU, Urgent Care, CLC Unit) just to name a few. Though we continue to make appointments (this helps us with time management) walk-ins are welcome for disability claims issues. We welcome social calls but ask that you limit them to as short as possible so we can focus on the work at hand. Remember we are here to assist you, so please reach out to us as the need arises. - **2.** Upcoming NVS Training. The office will be closed 20-24 April for the staff to attend NVS training in Annapolis MD and via Zoom. We will re-open on Thursday 25 April.
- **3.** Mid-Coast Veterans Council (MCVC) Outreach We will be available once again to assist veterans with claims at the MCVC 62 Pegasus St. in Brunswick (the old bowling alley at the old NAS Brunswick) look for the static P-3 A/C. We will meet with veterans from 10am to 4pm on Wednesday 13 March. Please call (207)406-4103 to

make an appointment, walk-ins are welcome. Please don't miss out on this opportunity to meet with our VSO's and get claims help and resource information.

4. VA Direct Deposit Policy Change for Multiple Accounts Starting April 20, 2024, VA will no longer send a veteran's or family members' benefit payments to more than one bank account. This will require all veterans and beneficiaries who receive GI bill payments and other benefit payments across multiple banking accounts to select one account by April 20, 2024. For example, if a veteran receives GI Bill payments to one of their bank accounts and disability compensation payments to another, they will need to consolidate and select one account for all payments by April 20, 2024. This shift will impact nearly 50,000 of 800,000 total GI Bill beneficiaries VA will be aggressively reaching out to these students through text message, phone, and email on a weekly basis through April 20. VA is also working with schools, Veterans Service Organizations, and other relevant parties to make sure that Veterans meet the deadline. The easiest way for beneficiaries to make this change is to log on to Change Your VA Direct Deposit Information | Veterans Affairs.

When they get to the pay information, there will be a box for the bank account information of their education benefit, and a box for the bank account information for the other benefit they receive. The beneficiary should then update the bank account information to use the same account for all benefits.

Importantly, no veteran will miss a benefits payment of any type. For any students who do not consolidate their bank accounts for benefits by April 20, VA will consolidate them on their behalf, electing their non-education benefit pay account as their primary bank account.

53% of Posts in the Department were eligible to vote at the Department Convention last year, this year my goal is 75%, let's all work together to meet that goal! Per National and State By-Laws, to vote at the State Convention you must have turned in all 4 Trustees Reports, 2 of which should have been turned in at this point with the next one due at the end of March. Your Post must also have been inspected, your Quartermaster must be Bonded, all monies owed to the Department must be paid. ALL Post and Districts are required to be incorporated, the opportunity to do that opened January 1st, 2024, make sure you are incorporated and registered with the State of Maine. Check the State Quartermasters hit list in these GOs to ensure you are aware of all these items and where you stand. Your Post is entitled to 1 delegate and 1 alternate per every 30 members in good standing as of March 31st and has paid a registration fee for every delegate. National makes their decision on the Post of the Year from each Department based on "impact" on National's dashboard. There is no longer any involvement from the Department.

Comrades, we need to do our due diligence when it comes to bringing in new members. We must adhere to the eligibility requirements set forth by the National Organization. We cannot let a person into the VFW without 100% verifying their eligibility, especially our Post Officers. It does not matter if they are your best friend, son,

brother, cousin, etc. If they don't have a medal, campaign ribbon, hostile fire pay, hazardous duty pay, combat badge, etc. that meet the VFW's criteria, they cannot join our organization. The National VFW website has posters and booklets outlining the eligibility criteria available free. They also have the Podium Edition available online for free as well that spells out what qualifies a person for membership. If you have any doubt, use your chain of command.
