VSO office is moving around the office space and splitting up James two desks to allow Brandon to use one. -VSO office will be reorganizing their workspace and moving desks, file cabinets and bookshelves. Will need a week to complete the move, request to close the office during this time to complete and late December around the holiday when it is slow would be the request if approved.

Membership: Program: We have 6 Posts that have completed a Recruiter Event and submitted the proper paperwork to me. We have 15 Posts and 1 District that need 10 or less Members to reach 100%. The Department is at 85.88% with 5356 Members. We need 880 Members to reach 100% and 943 Members to reach 101%. We have some work to do but can reach 100/101% this year. Many Posts are not doing anything to try and build their Membership up. Post Leadership need to interact with their Posts Members, so they know you care. They need to get involved and participate in community events. With the lack of interaction, we will see a decrease in Membership unless we get creative on the ways we do things. We need to continue with a positive attitude in our efforts towards reaching 100/101% across the board. Post Leadership must be creative with the way they seek Membership. Commanders and Membership Teams need to work those rosters to ensure they have reached all their members. We have to work really hard to keep the Members we have since we already did the work to get them. We need to reach out to those that have expired in the past and try again to get them back. More Recruiting Events need to take place. Bottom line we can't afford to sit back and wait we need to get out there and Recruit these Members.

Legislative: I was able to visit with all four of Maine's Legislators offices on September 9 & 10, 2025. I met Senator King and Senator Collins in person. Congresswoman Pingree and Congressman Golden were voting during my meeting time. I started off by stating the seven issues I would discuss. They were Community Care Reform, Major Richard Star Act, Transition from Service, Guard VA Benefit Act, more coverage of Toxic Exposure, Exploring Alternative PTSD Treatments and GI Bill Improvement. They were very receptive to our concerns. Right now, with budget issues it is hard to get anything else pushed through. We need to stay on all of our Legislators to ensure they follow through with what they say. We must continue to put pressure on our Legislators to hear our concerns and respond to them. We can do this by reaching out to them by email or by the call to action that are sent out. I recommend that more Members sign up for the VFW Action Corp. This will help spread the work of all the things the VFW is doing and other things going on that are important to Veterans. You do not have to be a VFW Member to sign up for it.

Finance: For the most part everyone is within their allotted budget. At this time, we are operating the green and it will get better once a few grants come in. Quartermaster Williams has stayed on top of our CD and we are making a lot of money because of it. He has kept me and the Commander informed and has done a great job keeping the Department in good order. Money is coming in slowly but we are expecting to get it so we are not too worried. This budget is very tight, and we must stay focused on staying within our individual budgets. Continue to keep doing what we are doing. Each Chairman and budget owner must work hard to stay within their allotted budget. It is our duty to be good stewards of the Departments monies.

District 1 > Cmdr Watson

Problem Areas: Area of Concern, Post 6187, Past Commander Paul Rediker, continues to battle cancer and

chemotherapy/radiation complications. He remains at the Caribou Veteran's Home; we continue to keep him in our thoughts and prayers. Continuing problem – 9389 Auxiliary – See District Commander.

Positive Areas:

Post 6187, Fort Fairfield, membership currently 86.88 %. Bonded. Ten flags flown daily. Loyalty and Memorial Day events hosted and open to the public. Posted flags at local cemeteries. Hosted day of Service food drive in honor of local First Responders, received 563.8 pounds of food and collected \$125. Raffled four Portland Sea Dogs tickets to those people who were eligible by donation of food items. Assisted Fort Fairfield Quality of Place Council in cleaning local roadways of litter. Coordinated with and purchased materials for senior seminar project for Emma Bragg. Ms. Braggs project created a poppy field surrounding the rear of the Post memorial. Two Post 6187 veterans served as her mentors. Facilitated a fishing event for eight elderly Veterans from the Maine Veterans Home. Collaborated with their Auxiliary to host a fund raiser for a local resident with pulmonary fibrosis in need of a double lung transplant, benefits raised exceeded \$15,000.00. Hosted a joint VFW/American Legion dignified flag retirement ceremony with Boy Scout Troop 194, utilized the event to teach the importance of flag etiquette and performed a narrated flag folding ceremony. Continues to support the Fort Fairfield Community and highlighted by the town for the entire duration of the 78th Annual Potato Blossom Festival, Including the opening ceremony at the Eagle Soar Veteran's Memorial, hosted the Festival Ball, Provided the Color Guard for the Parade and various other community events. During this time, a recruitment booth is held, as well as a three day basket raffle, who's proceeds go to their children's Christmas parties.

Post 9389, Caribou, membership currently 71.78%. Bonded. Post fly's US and POW/MIA flags daily. Post holds Bingo twice per week. Members volunteer with a food pantry each month for 4 hours. Members are active with the Red Cross monthly. Post donated hall two times for memorial luncheons and three Community events. Members served as military honor guards and flag presenters at a funeral. Members donated hall for veteran's cemetery meetings. Complete community service with handicapped students once a week. Post donated hall for Marine Corps league meetings. Post coordinates with the Agency on Aging to hold elderly meals at post each week starting in May plus the Carl Foundation meal support program. Post provides worked base learning opportunities for Job Corp Students at the post, they are mentored by two Post members. Post is held the 1st annual basket raffle in honor of Armed Forces Day and Day of Service. Post confirmed little league sponsorship for 2025. Post Commander continues to represent at VA clinic in PI for stake holder's group, also will continue to serve on Congressman Goldens vet panel for academy appointments. Post participated in multiple parades and ceremonies throughout northern Maine in support of District. Post Commander convinced city of Caribou to invest in Flags and poles for the city for Memorial Day, 4th of July and various other celebrations and services. Post will Provided two scholarships for High School Grads in 2025 from soda canteen funds. Post donated hall and cosponsored Ride for a Cure event, which was so well received that the following month donated the hall and cosponsored Brians ride, ATV events which encompassed numerous Maine ATV clubs. Shaun Smith, Adjutant Post 9389, recognized for his sustained and outstanding efforts to create a mural for the Post, which is proudly displayed on the outside of Post 9389. District and Post sponsored Memorial Day Parade held a ceremony at the city's veterans park and supported the Memorial Day Ceremony at the Maine Veterans Cemetery at Caribou. Post held a bylaws and informational training session with Post Auxiliary to ensure everyone in post knows what is authorized and not authorized as it relates to fundraising and how to ensure accountability is maintained with all funds collected while ensure no misrepresentation is potential in organization and or community. Reviewed how continued lack of following bylaws and procedures could relate to a potential loss of charter for the Auxiliary.
