It was a great privilege to be the National Council Member for Maine.

Membership: Program: The 2025 – 2026 Membership program is out. We have 23 Posts that have completed a Recruiter Event and submitted the proper paperwork to me. We have 33 Posts and 8 District that have reached or exceeded 100%. We have 20 of those Posts and 7 Districts that have reached 102% or more. We have 7 Posts and 1 District that need 10 or less Members to reach 100%. The Department is at 101.96% with 6385 Members. We need 3 Members to reach 102%. Great job by all I have no doubt we will hit this next milestone. We have some work to do but can reach 100/102% again this year. Many Posts waited until the last minute to make sure they met the requirements outline in the Membership program. Posts are not getting involved and participate in community events. We continue to have unpaid Post and District Officers. We need to continue with a positive attitude in our efforts towards the 2025-2026 VFW year and Membership program. The goal has been set and it is 101%! Post Leadership must be creative with the way they seek Membership. Commanders and Membership Teams need to work those rosters to ensure they have reached all their members. We have to work really hard to keep the Members we have since we already did the work to get them. We need to reach out to those that have expired in the pass and try again to get them back. More Recruiting Events need to take place. More of an effort needs to be put on community involvement. We can't afford to sit back and wait we need to get out there and Recruit New Members. Officers of your Post or District should never become unpaid. They should be setting the example and paying their dues on time or even early.

Legislative: At a National level the VFW is being heard and is gaining support for the GUARD VA Benefits Act and equal support to oppose the Veterans Choice Act. All four of our Legislators are on board with us and have supported the GUARD act. I have had both Senator King's and Congressman Golden's office reach out for support with their bills or comments for press releases. We have been seen at the State House and there is no doubt that they know we support LD -182 that will give permanent fund to Maine Veterans Homes. We continue to get support from our Legislators but we can't get bills like the GUARD Act, Major Richard Star Act, TAP assistance and many more passed. The Governors Budget was passed without the a line item for the Maine Veterans Homes so our only hopes are that LD -182 passes and is funded. We must continue to put pressure on our Legislators at the State and Federal level to hear our concerns and respond to them by passing these bills into laws. We can do this by reaching out to them by email or by the call to action that are sent out. I recommend that more Members sign up for the VFW Action Corp. This will help spread the work of all the things the VFW is doing and other things going on that are important to Veterans. You do not have to be a VFW Member to sign up for it.

Finance: The 2024 -2025 budget is on track and we are current operating in the black/green. We have established the 2025-2026 budget thanks to Quartermaster Williams. We continue to see profits from our CD since we are still getting some good rates. QM Williams did a great job keeping me informed and we have a good working relationship this past year. He continues to do a great job keeping the Department books and budget in good working order. A few individual budgets have gone over their budgets this year. The 2025-2026 budget is very tight with very little room for people to exceed their allotted budget. Continue to keep doing what we are doing. Each Chairman and budget owner must work hard to stay within their allotted budget. It is our duty to be good stewards of the Departments monies.

Update to complaint called to State Bingo Commission. Large shout out to the veterans of Post 9389 and others for successfully testifying to the state gaming commission and state elected members of the House. Their unrelenting drive and commitment lead the way for a rewrite of that portion of the law. We are now able to provide bingo games for children, fundraisers, events, carnivals, nursing homes, and schools. New Problem – 9389 Auxiliary – See District Commander.

Positive Areas:

Post 6187, Fort Fairfield, membership currently 114.81 %. Bonded. Ten flags flown daily. Coordinated with school administration on next year's VOD/PP joint topic, including September dates to brief the middle and high school. Planning on re-utilizing Scholar's App for VOD/PP administration. Coordinating with and purchased materials for senior seminar project for Emma Bragg. Ms. Braggs project will create a poppy field surrounding the rear of the Post memorial. Two Post 6187 veterans will serve as her mentors. Special thanks to the 6187-house committee, collaboration and efforts on a 100% reconstruction of the lounge area which upon completion is totally awesome. Utilized \$750 for a comrade in distress, Desert Storm Veteran requiring assistance for vehicle to continue commuting to work. Spring outreach begins in May, Loyalty Day and Day of Service planned. May 4 th day of Service highlighted nationally by VFW PR firm. Coordinated with Fort Fairfield Potato Blossom Festival planning committee on this years festival, July 12-20. Committee highlighting Post 6187 on 6 of the 9 days of festival. Post conducted general elections for 25-26 as well as delegated to state convention.

Post 9389, Caribou, membership currently 102.05%. Bonded. Post fly's US and POW/MIA flags daily. Post holds Bingo twice per week. Members volunteer with a food pantry each month for 4 hours. Members are active with the Red Cross monthly. Post donated hall two times for memorial luncheons and three Community events. Members served as military honor guards and flag presenters at a funeral. Members donated hall for veteran's cemetery meetings. Complete community service with handicapped students once a week. Post donated hall for Marine Corps league meetings.
